

INSPECTION

Carefully unpack and inspect your machine for shipping damage. Each unit is tested and thoroughly inspected before shipment, and any damage is the responsibility of the delivering carrier who should be notified immediately. Read all instructions carefully before operating.

CAUTION

To reduce the risk of ignition of Hazardous Atmospheres. Do not use in Class II, Group F locations that contain electrically conductive dusts.

WARNING

Models C88015-01 and C88015-03 dry pickup only --electric shock could occur if used outdoors or on wet surfaces.

WARNING

Models C88015-02 and C88015-04 wet and dry pickup--to avoid electric shock, use indoors only.

DANGER

This equipment is rated explosion proof and dust ignition proof only in areas listed below:

Class 1, Group D -- Atmospheres containing acetic acid (glacial), acetone, acrylonitrile, ammonia, benzene, butane, 1-butanol (butyl alcohol), 2-butanol (secondary butyl alcohol, n-butyl acetate, isobutyl acetate, sec-butyl alcohol, diisobutylene, ethane, ethanol (ethyl alcohol), ethylacetate, ethyl acrylate (inhibited) ethylene diamine (anhydrous), ethylene dichloride, gasoline, heptanes, haxanes, isoprene, isopropyl ether, mesityl oxide, methane (natural gas), methanol (methyl alcohol), 3-methyl-1-butanol (isoamyl alcohol), methyl ethyl ketone, methyl isobutyl ketone, 2-methyl-1 propanol (isobutyl alcohol), 2-methyl-2-propanol (tertiary butyl alcohol), petroleum naphtha, pyridine, octanes, pentanes, 1-pentanol (amyl alcohol), propane, 1-propanol (propyl alcohol), 2-propanol (isopropyl alcohol), propylene, styrene, toluene, vinyl acetate, vinyl chloride or xylenes.

Group F -- Atmospheres containing carbon black, charcoal, coal or coke dusts which have more than 8 percent total volatile material (carbon black per ASTM D1620, charcoal, coal and coke dusts per ASTM D271) or atmospheres containing these dusts sensitized by other materials so that they present an explosion hazard and having resistivity greater than 10² OHM -- centimeter but equal to or less than 10⁸ OHM -- centimeter.

Group G -- Atmospheres containing flour, starch, or grain or combustible plastics or chemical dusts having resistivity greater than 10⁸ OHM -- centimeter.

ELECTRICAL

The machine is designed to operate on 115 volt, 15 amp, 60 hertz AC circuit. This equipment is shipped with approved 3 wire grounded 14-3, 50' STWA power supply cord. No plug is supplied. Plug and wall receptacle should be wired by a qualified electrician in accordance with the National Electrical Code Standards in regard to hazardous locations, i.e. dust and vapor ignition. No extension cords should be used.

IMPORTANT SAFETY INSTRUCTIONS - SAVE THESE INSTRUCTIONS

Read all instructions before using:

- 1. Do not leave unattended when plugged in. Unplug from outlet when not in use and before servicing.
- 2. Use only for the intended use as described in this manual.

- 3. **Do not** operate with damaged cord or plug if equipment is not working properly, has been dropped, damaged, exposed to weather, or completely submerged, return it to Hako Minuteman for examination and repair.
- 4. Vacuum motor has no user serviceable parts and must be returned to the original equipment manufacturer for repair.
- 5. Do not pull or carry by supply cord, use cord as handle, close a door on cord, or pull cord around sharp edges or corners. Keep cord away from heated surfaces.
- 6. Do not disconnect plug by pulling on cord. To disconnect from outlet grasp the plug not the cord.
- 7. Do not operate without proper static dissipating dust bag or filters in place, nor assemble any other way than as shown in figures 1 through 4.
- 8. Do not use any attachment that has been changed in any way from its original design. Use no selfdesigned tools.
- 9. All lid and tank latches must be engaged before operation.

H.E.P.A. FILTER MODEL VACUUMS C88015-03 AND C88015-04

Minuteman hazardous-duty critical filter vacuum has been designed to clean up hazardous and toxic dust of all types. A special High Efficiency Particulate Air (H.E.P.A.) filter and a series of "prefilters" used with this vacuum reduce the incidence of airborne dust that would be created by any other method of cleaning.

During the removal of hazardous toxic dust, do not sweep, scoop, shovel or in any manner handle other than vacuuming.

Do not at any time attempt to bypass, remove, substitute or by any other means change the filters recommended for use with this vacuum. Use only approved Hako Minuteman filters and filter bags.

Do not at any time, or in any way, attempt to clean or remove dust particles that may collect or accumulate on the surface of the H.E.P.A. filter media.

Do not reverse or attempt to clean "prefilters" which have accumulated dust for the purpose of reusing them.

Hazardous materials must be disposed of properly. Never throw contaminated debris in your usual trash receptacle. Place debris in a plastic bag or can marked "HAZARDOUS MATERIALS" and take to a hazardous waste handler.

ASSEMBLY PROCEDURE FOR MODEL C88015-01 DRY ONLY

Follow assembly sequence as shown on page 4, figure 1:

- 1. Insert cloth filter bag (2), part #800251, into tank (3) using the formed rubber gasket to center it.
- 2. Place lid assembly (1), part #800250, on top of tank assembly (3) and secure in place by tank lid latches.
- 3. Insert metal end of grounded neoprene hose, part #800276, into hose intake on tank and tighten thumb screw to secure.
- 4. Attach tools desired as supplied on page 16.
- 5. Plug power supply cable into proper electrical outlet. You are now ready to pick up dry materials only. Reverse procedures above to empty.

ASSEMBLY PROCEDURE FOR MODEL C88015-03 DRY ONLY WITH H.E.P.A. FILTER

Follow assembly sequence as shown on page 4, figure 2:

- 1. Insert cloth filter bag (4), part #800251, into tank (5) using the formed rubber gasket to center it.
- 2. Place manometer ring (3) on top of tank assembly (5) and engage tank latches.
- 3. Place H.E.P.A. filter module (2) on top of tank assembly followed by lid assembly (1) and engage latches.
- 4. Insert metal end of grounded neoprene hose, part #800276, into hose intake on tank and tighten thumb screw to secure.
- 5. Attach tools desired as supplied on page 16.
- 6. Plug power supply cable into proper electrical outlet. You are now ready to pick up hazardous/toxic dry materials only.

Manometer ring assembly (3) will indicate when filters need cleaning or changing. Scale on gauge indicates performance.

PROCEDURE FOR REMOVING CONTAMINATED FILTER AND FOR CLEANING OF CONTAMINATED TANK OF MODEL C88015-03 DRY ONLY WITH H.E.P.A. FILTER

For the protection of your health, always wear the proper approved or required face mask, gloves and clothing as specified by your Safety Department for your particular application.

- 1. Unplug machine from power source.
- 2. Remove vacuum lid/motor assembly with H.E.P.A. filter.
- 3. Remove prefilter (1), page 9, and place in proper hazardous waste disposal container.
- 4. Gently remove the cloth filter bag assembly; recommended method of cleaning is by vacuuming with another H.E.P.A. vacuum.
- 5. Dispose of debris in tank assembly.

CAUTION: Hazardous materials, including disposable filters and pre-filters, must be disposed of properly. Never throw contaminated debris in your usual trash receptacle. Place debris in proper containers as recommended by your Safety Department.

All vacuum units should be properly tagged or labeled "HAZARDOUS MATERIAL" and should only be used by authorized, trained personnel.





ASSEMBLY PROCEDURE

Model C88015-02 wet vacuuming only when used for recovery of liquid hazardous materials (See schematic page 6, fig. 3)

- 1. Install liquid shut-off assembly (4) into tank assembly centering rubber gasket around rim of tank.
- 2. Place 1-to-1 adaptor (3) onto tank, center and snap lid latches into place.
- 3. Place the cloth filter bag (2) onto and into the adaptor using the formed rubber gasket to center it.
- 4. Position the vacuum lid assembly (1) onto the adaptor making sure that the lid is seated onto the rubber ring of the cloth bag frame completely around the tank. Snap lid latches into place. Liquid shut-off will activate at approximately the 8 gallon level, choking off vacuum.
- 5. Insert metal end of grounded neoprene hose, part #800276, into hose intake on tank and tighten thumb screw to secure.
- 6. Attach tools as desired as supplied on page 15.
- 7. Plug power supply cable in proper electrical outlet. You are now ready to pick up hazardous wet materials.

PROCEDURE FOR EMPTYING TANK

- 1. Unplug machine from power source.
- 2. Remove the vacuum lid assembly and place on work table(1).
- 3. Remove and inspect cloth filter bag for moisture. If bag is wet, allow to dry before reusing or replace with clean, dry filter bag (2).
- 4. Remove 1-to-1 adaptor (3).
- 5. Remove shut-off assembly (4).
- 6. Dispose of liquid waste in accordance with required procedures.
- 7. If tank assembly is elevated above container receiving waste, tilt tank on rear wheels by lowering carriage handle and dump waste into receiving container.

ASSEMBLY PROCEDURE

Model C88015-04 wet vacuuming only when used for recovery of liquid hazardous/toxic materials (See schematic page 6, fig. 4)

- 1. Install liquid shut-off assembly (6) into tank assembly centering rubber gasket around rim of tank.
- 2. Place 1-to-1 adaptor (5) onto tank, center and snap lid latches into place.
- 3. Place the cloth filter bag (4) onto and into the adaptor using the formed rubber gasket to center it.
- 4. Place manometer ring (3) on tank assembly and snap lid latches in place.
- 5. Place H.E.P.A. filter module (2) on tank, center rubber gasket around rim as shown.
- 6. Position the vacuum lid assembly (1) onto the adaptor making sure that the lid is seated onto the rubber ring of the cloth bag frame completely around the tank. Snap lid latches into place. Liquid shut-off will activate at approximately the 8 gallon level, choking off vacuum.
- 7. Insert metal end of grounded neoprene hose, part #800276, into hose intake on tank and tighten thumb screw to secure.
- 8. Attach tool as desired as supplied on page 15.
- 9. Plug power supply cable into proper electrical outlet. You are now ready to pick up hazardous/toxic wet materials.





- 4. Gently remove the cloth filter bag assembly; recommended method of cleaning is by vacuuming with another H.E.P.A. vacuum.
- 5. Remove float assembly (6), fig. 4.
- 6. Dispose of debris in tank assembly.


